Starting in July you can:

Designate your proxy online. Member-owners with a valid email on record with REC will receive instructions to vote online. Member-owners can also log in to MyREC SmartHub beginning July 1.

Complete and mail in your Proxy Designation Form when it arrives by U.S. Mail.

If you do not plan to participate in the virtual Annual Meeting on Aug. 9, you are encouraged to designate your proxy for the 2023 Director Elections. If you return a Proxy Designation form and then register to participate in the virtual Annual Meeting, your proxy designation form will be canceled.

If your preference is to participate in the virtual Annual Meeting, registration opens at 7 a.m. on Aug. 3 and closes at 5 p.m. on Aug. 4. Only registered members will receive instructions to join the virtual Annual Meeting on Aug. 9 to cast their vote live.
